



IS THE LAS CRUCES PARKS AND RECREATION MASTER PLAN?

WHAT?

- The City is currently undergoing a major update to it's Parks and Recreation Master Plan.
- The Master Plan is a visionary policy document that guides long-term decision-making of staff and elected and appointed officials on such things as capital expenditures, operations, staffing, etc.

WHY?

- The Master Plan helps create a vision for the recreation and public space opportunities within a community.
- The Master Plan identifies "levels of service" for the amount and location of future park space and recreational facilities.
- The Master Plan provides the City with a prioritized list of implementation actions to be phased in over time, as funding becomes available.



WHO?

- Halff Associates, Inc.
 was selected by

 facilitate the process
 and provide technical
 guidance.
- The community identifies park land and facility, and recreational programming issues and preferences.
- Following plan adoption, the City works with various partners to implement the plan.




IS THE PLAN IMPORTANT?

This Master Plan will help identify community preferences for the future and identify recommendations and priorities for the next five- to 10-years.



WHY IS THIS IMPORTANT?

- The Master Plan creates a "snapshot" of where the park system is now.
- The Master Plan creates an opportunity to identify changing community preferences about what is important to the citizens of Las Cruces.
- The Master Plan creates a forum for citizens to express what types of parks, amenities, and other recreation facilities they want.
- The Master Plan sets goals for parks, trails, open space, and recreation.
- The Master Plan helps the City apply for grants for indoor and outdoor park facility development.

LAS CRUCES

The provision of a high-quality public parks and recreation system is an essential component of building a "livable" community – one where all residents have access to the amenities and services that enhance our daily experiences with our neighbors and surrounding environment. A well distributed and managed system of park land and recreational amenities provides six essential community benefits.

HEALTH AND WELL-BEING



- Place for rest, relaxation, and revitalization.
- Areas for recreation activities (both active and passive).
- Provide opportunities to improve both physical and mental health.

SAFE HAVEN FOR YOUTH



- Safe place for unstructured activities.
- Supervised environment for healthy socialization by youth.

CONTRIBUTE TO ECONOMY



- Contributes to both increased property value and attractiveness for new residents.
- Opportunities for publicprivate partnerships.

INVOLVEMENT & SOCIALIZE



- Create a place for socialization and fellowship among neighbors and community members.
- Provide opportunities for community involvement.
- Areas often provide popular locations for community events.

INCREASE TOURISM



- Venues to host tournaments live music, and other events.
- Area to showcase a community's offerings and unique heritage.

PROMOTE CONSERVATION



- Promotion of wise use and stewardship of land.
- Opportunities to protect environmentally sensitive areas.



Understanding age distribution helps the City determine the needs for appropriate recreational opportunities for different age groups. For example, a toddler has different recreational needs than a teenager and a teenager has different needs than a 45 year old.

Analysis of the diversified age ranges found in Las Cruces illustrates the need to provide multi-generational parks and recreation which can adapt as the age of the population shifts.

Employment by Industry




Las Cruces can partner with a number of organizations across industry sectors to provide enhanced recreational opportunities to residents.

Las Cruces has grown significantly over the last 40 years. This growth has seen significant stagnation in recent years. As the population continues to grow, it is important to provide adequate parks and recreational opportunities for the larger community.

Individual Poverty Level Comparison



Las Cruces has a higher poverty level than that of the State of New Mexico but a lower poverty level than Doña Ana County. An adequate parks system is crucial for the development of underprivileged kids that need a safe place to play.

Las Cruces is more racially diverse than New Mexico and has a much higher percentage of residents of Hispanic or Latino descent. There may be additional opportunities for recreational activities, programs, and festivals that celebrate the heritage of the City's residents.




Residents in Las Cruces have higher education levels than that of Doña Ana County and the State of New Mexico. Providing the local workforce with additional learning and training opportunities can help equip them with higher level skill sets.

SERVICE AREAS

Quality provision of parks and recreation resources involves many components. One component is to ensure there is sufficient land dedicated to parks and recreation to meet the existing and future demands of the community. Another important component is to ensure there is sufficient distribution and access to parks and recreation facilities, amenities, and services throughout the City.


In this regard, parks systems are often analyzed to determine if there is sufficient "service area" coverage in all parts of the community. These analyses oftentimes identify both gaps and overlaps in the system. Different types of parks and recreation amenities serve different functions and consequently have different service areas.





Neighborhood parks typically serve a single neighborhood and are intended to serve residents within a 1/2-mile service area.

Community parks typically serve multiple neighborhoods and are intended to serve users who may drive to the park within a 2-mile service area.



Trails are intended to serve residents within a 1/2 mile service area, or within a 10-minute walk.

Indoor recreation facilities are typically accessed by car and are intended for use by the entire community.

SERVICE AREAS

During the master planning process the service areas of existing and planned city parks will be compared more closely to neighborhoods, subdivisions, and multi-family housing developments. This comparison will result in a much closer examination of the accessibility of the city parks to residents.

Service area and proximity of parks to homes is only one measure park land and facility "level of service." The master planning process will also consider the amount of park land per capita in Las Cruces, community preferences in recreational facility type, and special features in the community that may present a site-specific park or open space opportunity.

5 OF THE LAS CRUCES PARKS & RECREATION MASTER PLAN



The following preliminary goals have been identified in the 2012 Las Cruces Parks & Recreation Master Plan to guide the planning process and potential nearand long-term implementation actions. The goals are important because they provide the underlying philosophical framework for decisions that the City may make when evaluating need and potential next steps for the Las Cruces parks and recreation system. The goals are not listed in any particular order.

Goal 5: Protect and enhance Las Cruces's natural resources including plants, wildlife, and other ecologically sensitive areas.						
Goal 6: Strive for the efficient use of City resources while promoting aesthetically pleasing and functional parks and park facilities.						
Goal 7: Ensure parks are safe and comfortable environments for all park users.						
Goal 8: Provide a variety of multi-generational recreational experiences that appeal to all segments of the population of Las Cruces.						
Goal 9: Increase private sector involvement in developing and maintaining parks and open spaces throughout Las Cruces.						
Goal 10: Update codes and ordinances to ensure that a wide variety of parks, public gathering spaces, and connectivity options are integrated with neighborhoods and accessible to all citizens.



Mini Park


Two acres or less intended to serve the immediate neighborhood; often has a playground.



Two to 15 acres intended to serve a full neighborhood; often has a playground, picnic areas, small number of sports amenities.


Community Park

15 to 99 acres intended to serve people within two to five miles; includes numerous active (e.g., sports facilities, water recreation, etc.) and passive (e.g., picnic areas, trails, etc.) Recreation options.



Regional / Metropolitan Park

100 or more acres intended to serve multiple communities; includes activities which attract users from a wide area (e.g., large number of athletics, large natural areas, camping, etc.).




Greenbelt / Conservation Area

Preserved natural areas often available for passive recreation (e.g. trails, nature observation).



Social Spaces

Outdoor gathering areas such as plazas or open greens (e.g., Plaza de Las Cruces).




Special Park Uses

Parks developed to accommodate specialized recreation activities (e.g., aquatic facilities, golf course, skate park)



Linear Parks / Greenways

Parkland which generally follow a natural (e.g., creek) or man-made (e.g., utility easement) linear feature; often includes trails and public areas.



Indoor Facilities

E.g., gymnasium, pool, community center

SOALSPACES

Park spaces in typical traditional town and neighborhood design incorporated prominent social spaces such as plazas, paseos, squares and greens.






